Welcome to Lake City Dance Arts! Below is information that may be helpful in acquainting you with our program. If you have any questions, please feel free to contact the studio.

Communicating: NEWSLETTERS will be sent home at the beginning of each month that should include all the current information regarding the studio. Please check your child's dance bag the first of the month!! We will also post the newsletters on our website and at the lobby door. Feel free to call/text or leave a message at the desk if you have any questions. ALL COMMUNICATIONS WITH LCDA MUST GO THRU THE STUDIO AND NOT THE STAFF.

TEXTING seems to be the most efficient way of getting in touch with parents. You will not receive any group texts!!! The information that is sent applies specifically to you. Please confirm that you have received the text. Information will then be part of our conversations that can be re-read. We will not text with our students under the age of 18. Please forward to your child any info you think they need to see.

Tuition: Tuition is due at the first lesson of each month. Each student will have an average of four classes per month although some months may have three weeks and others may have five weeks. There will be no refunds for missed classes. TUITION FEES ARE OWED UNTIL WE ARE NOTIFIED THAT YOU ARE NO LONGER PARTICIPATING.

Dress Code: All Ballet, Jazz, Modern and Tap dancers are required to wear leotard and tights for class with optional black shorts. These classes require hair to be in a bun. Hip Hop students can wear leggings or athletic pants with a long t-shirt. Hair should be pulled back in a ponytail. Only studio Hip Hop shoes can be worn on the dance floors. Pre-school and Kindergarten students need a plain leotard in any color, without skirt, pink tights and hair pulled back out of the face. Students will be considered absent if they are not properly dressed. No loose jewelry. DANCE SHOES SHOULD NOT BE WORN OUTSIDE! This will ruin the shoes and our dance floors! Label all shoes, dancewear and accessories that you bring to the studio. Cover-ups should be worn in public.

Attendance: Regular attendance is extremely important in dance training. Each lesson is a planned progression of dance technique. Missing one session can affect the entire class. Please take attendance seriously and only miss classes due to illness. Perfect attendance awards (3 or less absences) will be given at the end of the year. Excessive tardies will also be considered for Perfect Attendance awards. The dance studio will be closed on Labor Day, Thanksgiving-1 week, Christmas-2 weeks and Spring Break-1 week. You will be notified of changes in our monthly newsletter. Please check the website, phone message or FB for weather cancellations.

Performances: We will perform at various community events throughout the year as well as our two dance recitals in June. Recital costume deposits will be due in December. Additional recital information will be given at a later date.

Conferences: Please do not converse with the teachers during class. Every student deserves our full attention for his or her entire class time. I will be happy to call you in the evenings or mornings to discuss any concerns. Once again...ALL COMMUNICATIONS WITH LCDA MUST GO THRU THE STUDIO AND NOT THE STAFF.

BEFORE LEAVING HOME

1. If you are sick or have been around anyone who is sick, please do not come to class!
2. Eat a snack, use the bathroom, wash your hands, dress for class, bring your own water with closed lid, bring dance shoes, check temperature. Limit drinks and sugar before class so less potty breaks.
3. Masks are not required at this time if protocol is maintained. Bring your own mask if you would prefer to wear one. Dancers are finding it hard to dance and breathe easily.

ARRIVAL AT THE STUDIO

1. Wait in your car until the lobby door opens showing that we are ready for you to enter.
2. No hugging or touching other dancers!
3. Enter through lobby door for a temperature check and get hand sanitizer from us. (It is faster to use ours and not your own unless it is medically necessary.)
4. Take belongings to dance room and find a "cubby" taped to the floor that has been properly spaced.
5. All parents and siblings must wait outside or in their cars. Bring a minimum number of extra people and watch spacing. Make sure your cell phone number is up to date in case we need you.
6. Payments can be made several ways: Cash, check or your bill pay program through your checking account will deliver payments to the studio with no fees attached. We are now capable of accepting payments on the website (LCDanceArts.com) but please consider that the studio is charged high fees for credit card service. Ms Pam will be at the door to greet you or payments can be sent in with your student. Receipts will be sent home with your student.

END OF CLASS

1. Change into street shoes while in the dance room.
2. Exit through the front door of the front dance room or lobby door if you dance in the back room after receiving our hand sanitizer on the way out. (Parents please be available for your child immediately, so they do not have to wait. Watch your social distancing while picking up your student.) We need time between classes to clean.

LCDA STAFF RESPONSIBILITIES

1. Studio will be sanitized between classes. (Dance room, door handles and bathroom fixtures)
2. Teachers will hand sanitize before and after class.
3. Teachers will wear face masks if required.
4. Our dance lines, spots and across-the-floor work will be spaced for social distancing.

PARENT/GUARDIAN AFFIDAVIT

You will have to decide with your family whether you want to participate in dance activities at LCDA. We will do everything we can to keep our studio a safe environment so we can get back to loving dance but completely understand that there are different opinions regarding this period in time. We all need to do what we can to protect others. We do ask that you sign this release to verify you are comfortable with returning to dance and that you have read and will abide by the protocol explained above. All students must have a signed form before starting classes.
